SUBJECT: Job 090723 FAP IM-49-1(23) Hwy. 71 – Hwy. 72 (Sel. Secs.) (Benton Co.) (S) Route 49, Section 29 Benton County Tier 1 Categorical Exclusion

The subject project is a pavement preservation job that proposes diamond grinding of 8.7 miles of Interstate 49 in Benton County. All work would be completed on select sections and within existing right of way. A project location map is attached.

The project would not involve relocations, endangered species, prime farmlands, wetlands, underground storage tanks, hazardous materials, any environmental justice issues, or cultural resources. This project has been determined to generate minimal air quality impacts for Clean Air Act criteria pollutants and has not been linked with any special mobile source air toxics concerns. The cultural resources clearance is attached.

The official species lists obtained through the US Fish and Wildlife Service's (USFWS) Information for Planning and Consultation identified the following species as potentially occurring within the project area: Gray Bat (*Myotis grisescens*), Indiana Bat (*Myotis sodalis*), Northern Long-eared Bat (*Myotis septentrionalis*), Ozark Big-eared Bat (*Corynorhinus townsendii ingens*), Tricolored Bat (*Perimyotis subflavus*), Eastern Black Rail (*Laterallus jamaicensis ssp. jamaicensis*), Piping Plover (*Charadrius melodus*), Red Knot (*Calidris canutus rufa*), Alligator Snapping Turtle (*Macrochelys temminckii*), Ozark Cavefish (*Amblyopsis rosae*), Neosho Mucket (*Lampsilis rafinesqueana*), Benton County Cave Crayfish (*Cambarus aculabrum*), Missouri bladderpod (*Physaria filiformis*), and Monarch Butterfly (*Danaus plexippus*). The official species list is attached. This project would have "no effect" on the aforementioned species due to the limited scope of the action, lack of suitable habitat, and distance to known species locations.

The Alligator Snapping Turtle is currently a proposed threatened species; the Tricolored Bat is a proposed endangered species, and the Monarch Butterfly is a candidate species; however, the proposed project would not jeopardize the continued existence of any of these species.

This project would not have a discharge of dredged or fill material into waters of the United States; therefore, a Section 404 permit will not be required.



SUBJECT: Cultural Resources Clearance Addendum Job 090723 Hwy. 71 – Hwy. 72 (Sel. Secs.) (Benton Co.) (S) Route I-49, Section 29 Benton County

This is a pavement preservation job that proposes an additional 2.598 miles of diamond grinding with rumble strips for a total of 8.71 miles. Work will be completed on sections of Interstate 49 between Highway 71 and Highway 72 in Benton County.

This project is subject to the 2021 Programmatic Agreement and falls under Activities C and F in Appendix B. The project is exempt from Section 106 review.
