**NOTICE**

Notice is hereby given that the Arkansas State Highway Commission has instituted an investigation into the application, or lack thereof, of the motor carriers shown on Exhibit A (attached hereto) who hold Arkansas intrastate operating authority. Ark. Code Ann §23-13-220(c) provides that one of the criteria for issuance of intrastate operating authority is “the likelihood of the proposed service being permanent and continuous throughout twelve (12) months of the year...”

Further, Ark. Code Ann §23-13-233(b) provides that the Commission may suspend or revoke, after notice and hearing, all or such part of the authority granted by any certificate which is not exercised reasonably continuously.

The Commission’s investigation has found that the carriers shown on Exhibit A have not completed the intrastate renewal registration required to maintain the authority in an active status for the previous two (2) year period, thus indication that operations have not been legally exercised in a reasonably continuous matter.

YOU ARE HEREBY NOTIFIED that the Commission will hold a hearing to determine whether the authorities shown on Exhibit A should be cancelled. Any carrier desiring to appear to show cause why said authority should not be cancelled must contact the Commission office in writing or by calling (501) 569-2355 to schedule a time to appear at such hearing. The date of said hearing shall be

In the office of the Arkansas State Highway and Transportation Department, Central Office, Room 802, 10324 Interstate 30, Little Rock, Arkansas.

Failure to appear on this date shall result in the cancellation of your authority to operate in Arkansas intrastate commerce. If you desire to appear to show cause why your authority should not be cancelled, you must schedule a hearing time on or before February 23, 2024, by calling the number shown above.
