

April 4, 2024

IT IS ORDERED that a meeting of the Arkansas State Highway Commission be opened at 10:00 a.m., April 4, 2024.

2024-015

WHEREAS, the Purchasing Committee has awarded purchases on February 12, February 13, February 26, and February 29, in the amounts of \$11,601,993.00, \$130,194.40, \$88,960.00, and \$1,227,925.00, respectively, totaling \$13,049,072.40, and supply and service contracts, in accordance with authority previously conveyed, all of which have been documented by official minutes which are of record in the files of the Commission and Equipment and Procurement Division.

NOW THEREFORE, IT IS ORDERED that the action of the Purchasing Committee be ratified and confirmed in all particulars.

2024-016

WHEREAS, Minute Order 2017-007 adopted the current Arkansas State Bicycle and Pedestrian Transportation Plan (Plan); and

WHEREAS, the Plan identified objectives and action strategies to accommodate and promote bicycle tourism in the State, including the development of a statewide bikeway network that connects to the United States Bicycle Route (USBR) System; and

WHEREAS, the USBR System is a nationwide network of city streets, county roads, trail systems, and state highways connecting urban and rural communities; and

WHEREAS, the American Association of State Highway and Transportation Officials (AASHTO) is responsible for approving designations of USBR routes; and

WHEREAS, Department staff, in coordination with other State agencies, local officials, and other stakeholders, have identified and documented support for designation of USBR 51 from the Missouri State Line to Alma, Arkansas.

NOW THEREFORE, the Director is authorized to apply to AASHTO for designation of USBR 51 from Missouri State Line to Alma, Arkansas as shown on the attached sketch.

WHEREAS, the collection of accurate traffic information is necessary for planning, designing, and maintaining highways; and

WHEREAS, the Department has entered into contracts to provide necessary traffic data since 2002; and

WHEREAS, work performed under these contracts has proven beneficial by providing innovative data collection techniques and supplementing in-house capabilities, allowing the Department's field personnel to perform other critical tasks; and

WHEREAS, the current contract is set to expire on December 31, 2024.

NOW THEREFORE, the Director is authorized to request proposals, select consulting firms, and enter into any necessary contracts and agreements with firms for on-call traffic data collection services as needs are identified.

WHEREAS, the Arkansas State Highway Commission (Commission) acquired property known as Tract No. 23R, Job No. R50084, from James B. Adcox and Mabel D. Adcox, husband and wife, by Warranty Deed dated November 24, 1997, and filed of record on December 12, 1997, in Deed Book I-16, Page 211, in the Circuit Clerk's office for Independence County, Arkansas; and

WHEREAS, Troy Warden and Sherry Warden of Pleasant Plains, Arkansas have requested to purchase Job No. R50084, Tract No. 23R, which the District Engineer for District 5 has determined is not now, nor in the foreseeable future will be, needed for highway purposes; and

WHEREAS, Tract No. 23R was acquired as surplus by the Commission and is exempt from reacquisition by the former owners under Ark. Code Ann. § 27-67-322. Troy Warden and Sherry Warden offered to purchase the tract for THREE THOUSAND AND NO/100 DOLLARS (\$3,000.00), representing a purchase price Seven Hundred Dollars (\$700.00) less than the Fair Market Value as determined by three qualified appraisers. The Assistant Chief Engineer - Design has approved acceptance of the Warden's offer; and

WHEREAS, the Commission acquired Tract No. 23R for FIVE HUNDRED TWENTY FIVE DOLLARS (\$525.00), which tract is more particularly described as follows:

Part of the Northeast Quarter of the Northeast Quarter of Section 22, Township 11 North, Range 6 West, Independence County, Arkansas, more particularly described as follows:

Starting at the Southwest Corner of the Northeast Quarter of the Northeast Quarter of Section 22; thence North 87° 44' 48" East along the South line thereof a distance of 370.91 feet to a point on the Southeasterly existing right of way line of U.S. Highway 107 for the point of beginning; thence North 23° 43' 22" East along the Easterly existing right of way line of U.S. Highway 167 a distance of 256.98 feet to a point on the Westerly proposed right of way line of Relocated U. S. Highway 167; thence South 81° 13' 35" East along said proposed right of

way line a distance of 66.44 feet to a point; thence South 08° 46' 25" West along said proposed right of way line a distance of 222.42 feet to a point on the South line of the Northeast Quarter of the Northeast Quarter of Section 22; thence South 87° 44' 48" West along said South line a distance of 135.23 feet to the point of beginning and containing 0.53 acre more or less.

NOW THEREFORE, the above-described property is declared surplus and upon receipt and consideration of the sum of THREE THOUSAND AND NO/100 DOLLARS (\$3,000.00) from Troy Warden and Sherry Warden of Pleasant Plains, Arkansas, the Chairman of the Commission is authorized and directed to execute a Quitclaim Deed conveying the right, title, interest or equity of the above-described properties to Troy Warden and Sherry Warden, husband and wife; and hereby releasing the same from the State Highway System, that the Right of Way Division is directed and authorized to record a copy of this Minute Order and the Quitclaim Deed in the records of Independence County, Arkansas; and, if necessary, the right of way shall be remonumented to reflect the boundaries designated herein. Any Federal-Aid funds from this disposal shall be credited to Federal-Aid funds or otherwise credited as permitted by Federal Law.

2024-019

WHEREAS, the City Council of Greenwood, by Resolution No. 120-20, has requested that the Highway 10 Bypass within the city limits of Greenwood, AR be designated as the "Trey Burgess Memorial Highway"; and

WHEREAS, the Arkansas Highway Commission has adopted guidelines for the installation of commemorative signs by Minute Order 2014-023 and this request meets these guidelines.

NOW THEREFORE, the Director is authorized to permit the installation of signs on each end of this Highway 10 Bypass, as requested by the City, in accordance with Commission Policy.

2024-020

WHEREAS, the City Council of Jacksonville, by Resolution No. 846, has requested that a section of Highway 67 within the city limits of Jacksonville, AR be designated as the "Distinguished Flying Cross Memorial Highway"; and



MOTION Commissioner Marie Holder moved, Commissioner David Haak seconded, and the motion passed to approve the Minutes from the February 13, 2024 Commission Meeting.

MOTION Commissioner Keith Gibson moved, Vice Chairman Philip Taldo seconded, and the motion passed to approve the submittal of the following grant applications:

Bridge Improvement Program (BIP) Grants – Highway 49  
Mississippi River Bridge (Helena Bridge)

Multimodal Project Discretionary Grant (MPDG) – Interstate  
49 project in Sebastian and Crawford Counties

MOTION The Commission approved Minute Order 2023-032 on April 5, 2023, authorizing the Department to engage the services of a qualified consulting firm to provide Nondestructive Testing (NDT) of concrete bridge decks. Public advertisement was made on July 16, 2023, in the Arkansas Democrat-Gazette and on the Department's website. Commissioner Keith Gibson moved, Commissioner Marie Holder seconded, and the motion passed to approve Staff's recommendation to select the following firm to provide NDT of concrete bridge decks:

Bridge Diagnostics, Inc. – Louisville, Colorado

#### OTHER DISCUSSION ITEMS

Patrick Patton, Chief Fiscal Officer, provided the February 2024 State Highway Revenue update. For State Fiscal Year (SFY) 2024 Budgeted vs. Actual Operating Expenses for ARDOT, overall expenses (maintenance, operations, administrative, and construction) were below budget by -13.1% (-\$16.1 million). Mr. Patton noted that State Highway Revenues to the Department from traditional sources for the year were up a total of 2.3% (\$10.6 million) in State Fiscal Year (SFY) 2024 compared to SFY 2023. Revenue from the Natural Gas Severance Tax was lower compared to the previous year. Total revenues available in SFY 2024 were -4.5% (-\$23.1 million) below last year. Actual State

Revenue received was -5.4% (-\$27.0 million) below projected (budgeted) revenue for the year.

Kevin Thornton, Chief of Administration, provided the Federal and State Legislative updates to the Commission. Congress and the President have agreed upon a spending bill for the remainder of Federal Fiscal Year (FFY) 2024. This provides funding until September 30. The bill provides full funding for all formula and discretionary grant programs within the IJA, as well as a new bridge discretionary grant program. The bill also provides additional funding for the following six projects:

- Interstate 49 from Barling to Alma - \$67 million requested by Senator Boozman.
- Construction of Future Interstate 57 from Walnut Ridge to the Missouri State line - \$6 million requested by Senator Boozman and Representative Crawford.
- Highway 10 Greenwood Bypass - \$5 million requested by Representative Womack.
- Highway 82 Corridor improvements in Ashley, Chicot, Columbia, and Union Counties - \$5 million requested by Senator Boozman and Representative Westerman.
- Highway 412 and Interstate 49 for improvements to the interchange of Highway 412 and Interstate 49 - \$5 million requested by Senator Boozman and Representative Womack.
- Highway 412 corridor for improvements in northern Arkansas - \$3 million requested by Senator Boozman and Representative Crawford.

When the \$91 million awarded for FFY 2024 is combined with the previously awarded amounts from 2022 and 2023, Arkansas has received nearly \$200 million in additional funding.

Thornton also updated the Commission on the 2024 Fiscal Session of the 94<sup>th</sup> General Assembly, scheduled to begin on April 10. The fiscal session is anticipated to last up to 30 days and will conclude in early May.

Crystal Woods, Assistant Chief of Administration, provided an update on the Arkansas Legislative Council Efficiency Study Recommendations Rules for Implementation. The monthly reports for February, March and April 2024 were submitted and addressed the following recommendations:

- Recommendation #1 noted that the Department should "Finalize KPIs and implement performance management".



- The final KPI dashboard has been approved by the Oversight Committee and has been posted to ARDOT’s website.
- Recommendation #12 and #13 noted that the Department should “Ensure staff can develop in their careers at ARDOT” and “Improve staff capabilities to align with current/future organizational needs”.
  - The final phase of the Maintenance Training Academy is to offer equipment operation training to employees via simulator. The 2024 training schedule has been developed and gives employees the opportunity to learn basic operator skills on a backhoe, wheel loader, motor grader and excavator in a safe, controlled environment.

Woods also presented an overall update of the implementation of the recommendations. Within the 13 recommendations are 90 rules that will be completed. To date, the Department has completed 57 of these rules. There is also one recommendation has been fully implemented.

Keli Wylie, Assistant Chief Engineer – Program Delivery provided the bid letting update from the February 28, 2024, bid letting.

Rex Vines, Chief Engineer – Operations provided an update to the Interstate 30 Saline County Default Recommendation. ARDOT, Johnson Brothers Construction (JBC) and the Surety were able to reach an agreement to allow JBC to remain on the project. No action was taken on proceeding with the recommendation to default.

Vines concluded his presentation with a recap of the March 31, 2023 tornado responses in Little Rock and Wynne.

Steve Frisbee, Assistant Chief Engineer – Maintenance updated the Commission on the Department’s final preparation for the 2024 total solar eclipse on April 8, 2024.

Director Tudor updated the Commission on recent Department activities. Since the February 13 meeting, several noteworthy Department activities occurred as listed below:

- Director Tudor served as a panelist at the Arkansas Lithium Innovation Summit in Little Rock on February 16.
- Chairman Farmer, Commissioner Holder, and Jared Wiley participated in the annual Arkansas Leadership Class in Jonesboro on February 21.

- Director Tudor and Jared Wiley attended the Governor’s Conference on Tourism in Jonesboro on February 26, where Director Tudor participated in a panel discussing the total solar eclipse.
- Commissioner Keith Gibson and Director Tudor attended the Fort Smith Chamber of Commerce 1<sup>st</sup> Friday Breakfast on March 1.
- Following the Chamber Breakfast, Commissioner Gibson and Director Tudor were joined by Vice Chairman Taldo at the Highway 10 Greenwood Bypass Groundbreaking.
- Director Tudor participated in a joint press conference with the Governor and various other state agencies on March 4.
- Director Tudor spoke at a Women in Construction Luncheon in Little Rock on March 6.
- Director Tudor appeared on an Arkansas PBS program to discuss preparations for the eclipse on March 15.
- On March 19 Director Tudor and Dave Parker spoke at the 2024 Southeast Pavement Preservation Partnership Meeting in Hot Springs.

Jared Wiley, Chief Engineer of Preconstruction presented on the Local Programs Division.

Director Tudor presented a list of upcoming meetings and events that the Director and Commission will be attending.

Director Tudor recognized noteworthy accomplishments of the Department. In March 2024 ARDOT bridge repair crews were able to complete structural repairs to the Highway 20 bridge in Phillips County, allowing the removal of a load posting. Also in March, ARDOT was presented with engineering excellence awards by the American Council of Engineering Companies of Arkansas for three projects. Director Tudor recognized Leslie Coddington, who recently rejoined the Department as the Assistant Chief Fiscal Officer. Tudor also recognized three District Engineers who have are or are retiring this year and welcomed the newest District Engineers who stepped into those vacated positions. In closing, Director Tudor unveiled the proposed workers memorial, which will be a permanent structure located at the Central Office complex.
