

2025-001

IT IS ORDERED that a meeting of the Arkansas State Highway Commission be opened at 10:00 a.m., February 19, 2025.

2025-002

WHEREAS, the Purchasing Committee has awarded purchases on November 25, December 10, and December 23, 2024 and January 28, 2025, in the amounts of \$107,239.68, \$693,949.19, \$4,701,005.24, and \$6,283,806.00, respectively, totaling \$11,786,000.11, and supply and service contracts, in accordance with authority previously conveyed, all of which have been documented by official minutes which are of record in the files of the Commission and Equipment and Procurement Division.

NOW THEREFORE, IT IS ORDERED that the action of the Purchasing Committee be ratified and confirmed in all particulars.

2025-003

WHEREAS, the American Association of State Highway and Transportation Officials (AASHTO) has billed the Arkansas Department of Transportation for membership dues for the year 2025; and

WHEREAS, this membership is regarded as being highly beneficial to the Department.

NOW THEREFORE, IT IS ORDERED that the Director is authorized to process payment for AASHTO membership dues for the year 2025 in the amount of \$42,365.76.

2025-004

WHEREAS, the Highway System in Arkansas facilitates safe mobility, economic development, and tourism enhancement throughout the State; and

WHEREAS, public information and education activities play an important role in providing the citizens of our State with pertinent information relative to the issues facing the Commission and Department; and

WHEREAS, the Arkansas Good Roads Foundation serves as an effective group to provide this information and education to transportation stakeholders, elected officials, and the public.

NOW THEREFORE, the Director is authorized to make a contribution of \$40,000 to the Arkansas Good Roads Foundation for its public information and education activities for the time period January 1, 2025, through December 31, 2025.

2025-005

WHEREAS, a pooled fund study titled, “Performance Based Specifications of Fiber Reinforced Concrete”, has been established by the Federal Highway Administration; and

WHEREAS, this pooled fund study will develop test methods to predict fiber reinforced concrete performance, performance-based specifications to ensure design goals are achieved, and guidance documents for fiber reinforced concrete design and troubleshooting; and

WHEREAS, developing specifications for materials and test methods for fiber reinforced concrete would expand opportunities for its use by the Department; and

WHEREAS, this pooled fund study is eligible for State Planning and Research funds without non-Federal matching funds.

NOW THEREFORE, the Director is authorized to participate in this pooled fund study and enter into necessary agreements to fulfill the Department's commitment.

2025-006

WHEREAS, the Infrastructure Investment and Jobs Act (IIJA) requires states to develop, maintain and update State Freight Plans at a frequency of no less than every four years; and

WHEREAS, the purpose of a State Freight Plan is to assess freight conditions and needs, establish freight goals, objectives, and implementation strategies, and to identify potential freight projects, in consultation with the State Freight Advisory Committee; and

WHEREAS, the current Arkansas State Freight Plan was adopted in December 2022 by Minute Order 2022-108; and

WHEREAS, an update to the Arkansas State Freight Plan is necessary to comply with federal regulations; and

WHEREAS, consultant services have been found to be an effective method of providing expertise and capacity to Department staff for freight planning efforts.

NOW THEREFORE, the Director is authorized to engage the services of a qualified consulting firm for the purpose of updating the Arkansas State Freight Plan.

2025-007

WHEREAS, the Arkansas State Highway Commission (Commission) acquired property known as Tract No. 25, Job No. 040716, from Arkansas Colleges of Health Education, a Corporation Duly Organized and Existing Under the Laws of the State of Arkansas, by Warranty Deed dated July 22, 2021, and filed of record on October 23, 2021, as Document No. 2021-19111, in the Circuit Clerk's office for **Sebastian** County, Arkansas; and

WHEREAS, the City of Fort Smith, Arkansas, has requested that portion of said right of way be transferred to it pursuant to Ark. Code Ann. § 27-65-109, for transportation purposes; and

WHEREAS, the City's request is more specifically described as detailed by the Legal Description in Exhibit "A" and areas shown in red and depicted on Exhibits "B" and "C" attached hereto.

NOW THEREFORE, the Director is authorized to enter into a transfer agreement for the above-described properties pursuant to Minute Order 2012-008, conditioned upon the City's continued maintenance of the property interests herein transferred for said highway purposes, and provided that in the event the City fails to use and maintain the properties described herein, or abandons same, the transfer agreement shall, upon 30 days notice, be terminated, and the transferred property shall revert back to the Commission.

2025-008

WHEREAS, the Arkansas State Highway Commission (Commission) acquired property known as Tract 99XR, Job 070367, from John H. Hays and Carolane Jones Hays, by Warranty Deed dated July 11, 2022, and filed of record on July 13, 2022, in Instrument Number 2022R005107, in the Circuit Clerk's office for Union County, Arkansas; and

WHEREAS, the Arkansas State Highway Commission (Commission) acquired property known as Tract 103XR, Job 070367, from Billy Blann and Judy Blann, a married couple, by Warranty Deed dated November 10, 2022, and filed of record on November 14, 2022, in Instrument Number 2022R008166, in the Circuit Clerk's office for Union County, Arkansas; and

WHEREAS, South Arkansas College has requested to purchase Tracts 99XR and 103XR, Job 070367, which the District Engineer for District 7 has determined are not now, nor in the foreseeable future will be, needed for highway purposes; and

WHEREAS, Tracts 99XR and 103XR were acquired as surplus by the Commission and are exempt from reacquisition by the former owners under Ark. Code Ann. § 27-67-322; and

WHEREAS, South Arkansas College offered to purchase the tracts for FIFTY THOUSAND EIGHT HUNDRED DOLLARS (\$50,800.00), representing the

fair market value as determined as of September 3, 2024 by two qualified appraisers; and

WHEREAS, the Commission acquired Tract 99XR for NINE THOUSAND SIX HUNDRED DOLLARS (\$9,600.00), which Tract 99XR is more particularly described as follows:

Part of Lot 125 of Newton Subdivision to the City El Dorado, Union County, Arkansas, being part of the Southeast Quarter of the Southeast Quarter of Section 29, Township 17 South, Range 15 West, Union County, Arkansas, more particularly described as follows:

Commencing at a point being used as the Southeast Corner of said Section 29; thence North 00°20'15" East along the East line of said Section 29 a distance of 145.27 feet to a point; thence North 89°39'45" West a distance of 31.24 feet to a point on the East line of Lot 125 of Newton Subdivision to the City El Dorado, said point being on the West right of way line of line of U.S. Highway 167B (West Avenue) as shown on a Plat of The Original Town of El Dorado filed in Plat Cabinet 1 at Slide 310; thence South 89°50'40" West a distance of 16.48 feet to a point on the North right of way line of U.S. Highway 82B (W. Hillsboro Street) as established by ARDOT Job 070367 for the POINT OF BEGINNING; thence South 32°45'06" West along said right of way line a distance of 71.24 feet to a point; thence South 69°00'59" West along said right of way line a distance of 94.36 feet to a point; thence North 01°31'28" East a distance of 83.02 feet to a point; thence North 87°19'56" East a distance of 11.88 feet to a point; thence North 02°01'21" East a distance of 9.86 feet to a point; thence North 89°50'40" East a distance of 112.23 feet to the POINT OF BEGINNING and containing 0.18 acres (7,663 square feet) more or less, as shown on plans referenced as ARDOT Job 070367.

WHEREAS, the Commission acquired Tract 103XR for EIGHT THOUSAND NINE HUNDRED DOLLARS (\$8,900.00), which Tract 103XR is more particularly described as follows:

Part of Lots 33 and 34, Block 45 of the Original Plat of El Dorado, Union County, Arkansas, being part of the Southwest Quarter of the Southwest Quarter of Section 28, Township 17 South, Range 15 West, Union County, Arkansas, more particularly described as follows:

Commencing at a point being used as the Southwest Corner of said Section 28; thence South 88°12'59" East along the South line of said Section 28 a distance

of 359.45 feet to a point; thence North 01°47'01" East a distance of 44.68 feet to a point on the North right of way line of U.S. Highway 82B (W. Hillsboro Street); thence North 88°54'29" West along said right of way line a distance of 194.04 feet to a point; thence North 01°39'40" East a distance of 28.42 feet to a point on the North right of way line of U.S. Highway 82B (W. Hillsboro Street) as established by ARDOT Job 070367 for the POINT OF BEGINNING; thence South 51°51'34" West along said right of way line a distance of 18.04 feet to a point; thence North 89°47'20" West along said right of way line a distance of 48.85 feet to a point; thence North 36°56'17" West along said right of way line a distance of 59.14 feet to a point; thence North 22°00'00" West along said right of way line a distance of 79.71 feet to a point; thence North 00°07'10" West a distance of 42.16 feet to a point on the North line of Lot 33, Block 45 of the Original Plat of the City of El Dorado; thence South 89°04'35" East along the North line of Lot 33 and Lot 32 of said Block 45 a distance of 132.90 feet to a point on the North line of Lot 32, of said Block 45; thence South 01°39'40" West a distance of 150.29 feet to the POINT OF BEGINNING and containing 0.40 acres (17,747 square feet) more or less, as shown on plans referenced as AHTD Job 070367.

NOW THEREFORE, the above-described property is declared surplus and upon receipt and consideration of the sum of FIFTY THOUSAND EIGHT HUNDRED DOLLARS (\$50,800.00) from South Arkansas College, the Chairman of the Commission is authorized and directed to execute a Quitclaim Deed conveying the right, title, interest or equity of the above-described properties to South Arkansas College; and hereby releasing the same from the State Highway System, that the Right of Way Division is directed and authorized to record a copy of this Minute Order and the Quitclaim Deed in the records of Union County, Arkansas; and, if necessary, the right of way shall be remonumented to reflect the boundaries designated herein. Any Federal-Aid funds from this disposal shall be credited to Federal-Aid funds or otherwise credited as permitted by Federal Law.

2025-009

WHEREAS, the Arkansas State Highway Commission ("Commission") acquired property for highway rights of way for Job No. 8462 in Johnson County, Arkansas; and

WHEREAS, the City of Clarksville, Arkansas ("City") has requested that the property be transferred to the City pursuant to Ark. Code Ann. § 27-65-109, for

future transportation and maintenance purposes adjacent to the existing highway; and

WHEREAS, the Commission's interest in the property subject of the City's request is more specifically described as detailed by the Legal Description in Exhibit "A" and areas shown in red and depicted on Exhibits "B" and "C" attached hereto.

NOW THEREFORE, upon receipt of a proper resolution from the City, the Director is authorized to enter into a transfer agreement for the above-described property pursuant to Minute Order 2012-008, conditioned upon the City's continued maintenance of the property interests herein transferred for said highway purposes, and provided that in the event the City fails to use and maintain the properties described herein, or abandons same, the transfer agreement shall, upon 30 days notice, be terminated, and the transferred property shall revert back to the Commission.

2025-010

WHEREAS, IN PHILLIPS COUNTY, a contract dated April 10, 2024 was awarded to Atlas Asphalt, Inc. for Job No. SA5450, FAP No. 9970, Phillips Co. Overlay & Rehab. (S), based on a low bid of \$395,592.44; and

WHEREAS, the County is unable to fulfill the requirements to bring the project to a suitable condition for the contract work to be performed; and

WHEREAS, the Phillips County Judge and the Contractor have requested that Job No. SA5450, FAP No. 9970, Phillips Co. Overlay & Rehab. (S) be canceled due to a substantial increase in the nature and scope of work required for the project, exceeding the scope of work under the original contract.

NOW THEREFORE, IT IS ORDERED that the Director is authorized to take the necessary steps to cancel the contract for Job No. SA5450, FAP No. 9970, Phillips Co. Overlay & Rehab. (S).

2025-011

WHEREAS, IN OUACHITA COUNTY, the Highway 79, Highway 79B, and Highway 278 intersection near East Camden was identified as in need of safety improvements; and

WHEREAS, an ongoing statewide study has prioritized rural intersections for improvements based on fatal and suspected serious injury crash histories; and

WHEREAS, the Arkansas Strategic Highway Safety Plan (2022) identified intersections as a focus area under the Safe Roads element; and

WHEREAS, this work is eligible for Federal-aid Highway Safety Improvement Program funds.

NOW THEREFORE, the Director is authorized to proceed with plans and construction of a safety improvement project at this location, as shown on the attached map, as funds become available.

2025-012

WHEREAS, IN PULASKI COUNTY, the Institutional Drive System maintained by the Department at the Arkansas Department of Veterans Affairs Veterans Home was recently reviewed; and

WHEREAS, the Veterans Home and drives in Little Rock have been obliterated; and

WHEREAS, a new Veterans Home and drives were constructed in North Little Rock; and

WHEREAS, the new drives meet the criteria for inclusion into the State Maintenance System as established by Commission Policy 4201 on August 2, 1961.

NOW THEREFORE, IT IS ORDERED, that upon official notification by the Chief Engineer – Preconstruction, drives at the Veterans Home in North Little Rock, as shown on the attached sketch, are hereby to be maintained by the Department as State Highway 885, Section 1.

2025-013

WHEREAS, Resident Engineer Offices 73 and 74 are located near one another in Camden; and

WHEREAS, Resident Engineer 73 also operates out of a sub-office located in Arkadelphia; and

WHEREAS, it is no longer necessary to operate Resident Engineer 73 office in two separate locations; and

WHEREAS, closing Resident Engineer Office 73 in Camden and moving the office to the Arkadelphia area allows the District to provide for more efficient inspection of construction jobs throughout their eight counties; and

WHEREAS, the existing sub-office facility is not adequately sized and cannot be expanded to accommodate staffing for full operations.

NOW THEREFORE, the Director is authorized to either purchase and modify an existing property to meet the needs of the office, or identify the most appropriate location for a new facility, acquire the necessary property, and construct a new Resident Engineer's Office, which includes buildings, appurtenances, fencing, and related items as funds become available.

2025-014

WHEREAS, the existing property serving as the Montgomery County Area Headquarters, near Pencil Bluff on Highway 270, is marginal in size; and

WHEREAS, an additional adjoining property of approximately 2 acres is available; and

WHEREAS, enlarging the size of the existing property would better accommodate the need for equipment parking and materials storage.

NOW THEREFORE, the Director is authorized to purchase the additional property and make improvements including reconfiguring of the parking, fencing, and related items as funds become available.

2025-015

WHEREAS, IN SHARP COUNTY, IN THE CITY OF ASH FLAT, Bridge Number 19622 located on Peace Valley Road was recently closed to protect the safety of the traveling public when an on-site inspection determined the superstructure to be in critical condition; and

WHEREAS, the timely replacement of this bridge is critical in order to restore normal traffic flow and maintain adequate transportation services in the area; and

WHEREAS, the City of Ash Flat has requested to partner with the Department and Sharp County to expedite the reopening of Peace Valley Road; and

WHEREAS, under the proposal, the Department would provide funding to the City necessary for replacing the bridge in return for the removal of mileage from the highway system; and

WHEREAS, Sharp County has agreed to accept ownership of and responsibility for a portion of Highway 175, Section 1 to offset the funding necessary for the bridge replacement.

NOW THEREFORE, the Director is authorized to enter into any necessary agreements with Sharp County and the City of Ash Flat to make funding available for this project.

FURTHERMORE, upon official notification by the Chief Engineer – Preconstruction, a select portion of Highway 175, Section 1 of sufficient length will be removed from the State Highway System to offset the cost of the bridge replacement through future deferred maintenance.

MOTIONS

MOTION Vice Chairman Keith Gibson moved, Commissioner David Haak seconded, and the motion passed to approve the Minutes from the December 3 and December 4, 2024 Commission Meetings.

MOTION Commissioner Marie Holder moved, Vice Chairman Keith Gibson seconded, and the motion passed to submit an application for the Competitive Highway Bridge Program (CHBP) for the Interstate 30 Bridge Deck Rehabilitation project in Little Rock.

OTHER DISCUSSION ITEMS

Patrick Patton, Chief Fiscal Officer, provided the January 2025 State Highway Revenue update. For State Fiscal Year (SFY) 2025 Budgeted vs. Actual Operating Expenses for ARDOT, overall expenses (maintenance, operations, administrative, and

construction) were below budget by -20.3% (-\$23.9 million). Mr. Patton noted that State Highway Revenues to the Department from traditional sources for the year were below budget a total of -1.8% (-\$8.9 million) in SFY 2025. Revenue from the Natural Gas Severance Tax was equal to the budgeted amount (\$4.0 million). Actual revenue through January 2025 is -1.8% (-\$8.6 million) below budget.

Kevin Thornton, Chief of Administration, provided an update on Federal and State legislative activities. At the state level, Thornton updated on the Regular Session and the status of bills related to ARDOT's legislative package. On the Federal level, Thornton reported that a Continuing Resolution (CR) was still in effect through March 14. If Congress and the President cannot agree on an appropriation bill by this deadline, another CR will have to be enacted to prevent a partial shutdown of the government. Thornton also briefed the Commission on the transition from President Biden's administration to President Trump's administration, including the various program funding that has been paused. Currently, programs affected by this pause include the National Electric Vehicle Infrastructure (NEVI), Discretionary Grants, Supportive Services for Disadvantaged Business Enterprise (DBE) and Supportive Services for On-the-Job Training. Administration is monitoring these programs and will continue to update as new information is available.

Crystal Woods, Assistant Chief of Administration, provided an update on the Arkansas Legislative Council Efficiency Study Recommendations Rules for Implementation.

- Recommendation # 1 noted that the Department should "finalize KPIs and implement performance management".
 - Staff has developed a formal set of Procedures for *Identifying and Reviewing Key Performance Indicators* for recommending KPIs and maintaining the performance dashboard.
 - This recommendation is considered fully implemented.
- Recommendation #6 noted that the Department should "implement construction contractor performance measurement".
 - Metrics were identified and adopted and included in the Prime Contractor Performance Report Manual.
 - The evaluation form and scoring process used during the seven-project pilot have been adopted and included in the manual
 - Guidance is currently being developed for the type or size of projects where the evaluation will or will not be used.

Woods also presented an overall update of the implementation of the recommendations. Within the 13 recommendations are 90 rules that will be completed. To date, the Department has completed 75 (83%) of these rules. Six recommendations have been fully implemented.

Jessie Jones, Chief Engineer – Preconstruction provided the bid letting update from the January 15, 2025 bid letting.

Rex Vines, Chief Engineer – Operations provided a construction and maintenance activity update, which included the Department's response to the recent winter weather.

Director Wiley updated the Commission on recent Department activities. Since the December 4 meeting, several noteworthy Department activities occurred as listed below:

- Throughout the month of December, Administration and Staff traveled to all ten Districts and the Central Office for their annual Service Awards ceremonies.
- ARDOT hosted its Legislative Orientation at the Central Office in Little Rock on January 15.
- Commissioner Jerry L. Halsey, Jr. was sworn in as the newest Highway Commissioner and met with Director Wiley on January 23.
- Director Wiley spoke at the Associated General Contractors of Arkansas's Lunch and Learn event in Morrilton on January 29.
- Former Director Lorie Tudor was honored with a resolution in the House of Representatives, recognizing her 41 years of service to the State of Arkansas, including her last 5 years as Director.
- On January 31, Chairman Philip Taldo and Vice Chairman Keith Gibson attended the ribbon cutting ceremony for the Mulberry River Bridge.
- Chairman Taldo presented to the Northwest Arkansas Board of Realtors meeting in Lowell on February 6.
- Director Jared Wiley hosted Jim Tymon, Executive Director of the American Association of State Highway and Transportation Officials (AASHTO) for an introductory meeting on February 11.

Director Wiley gave a look back at the previous year - progress, accomplishments, significant events, etc. and an overview of what lies ahead for 2025.

Jessie Jones, Chief Engineer – Preconstruction, Rex Vines, Chief Engineer – Operations, and Kevin Thornton, Chief of Administration each gave an overview of their areas of responsibility.


Director Wiley provided a list of upcoming events.

In closing, Director Wiley notified the Commission of recent grant awards. The Environmental Division received a grant for \$134,000 for the Roadside Pollinator Program for the Wiseman Mitigation Bank property in Izard County. Additionally, the U.S. Department of Transportation announced the recipients of the 2025 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grants on January 31 for the Corning Bypass (Future I-57) in the amount of \$24.9 million, and for Highway 112 in Benton and Washington Counties in the amount of \$25 million. Director Wiley recognized Commissioner Marie Holder, who recently accepted the Women's Transportation Seminar's (WTS) Employer of the Award on ARDOT's behalf. Lastly, Director Wiley highlighted recent Highway Police activities, specifically the newly revived K-9 program. On February 10 Highway Police's newest K-9 officer, Mack, alerted to the presence of drugs during a safety inspection. A shipment of illegal marijuana totaling approximately 4,900 pounds and a street value of over \$16 million was discovered. The next day, another inspection uncovered approximately 4,915 pounds of marijuana valued over \$16 million.
