RESOLUTION # 6-2024

A RESOLUTION BY THE POLICY BOARD OF THE TEXARKANA METROPOLITAN PLANNING ORGANIZATION (MPO) ADOPTING AMENDMENT THREE TO THE FY 2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) FOR THE ARKANSAS PORTION OF THE TEXARKANA METROPOLITAN STUDY AREA AND AUTHORIZING ITS SUBMISSION TO THE ARKANSAS DEPARTMENT OF TRANSPORTATION (ARDOT).

WHEREAS, the Texarkana Urban Transportation Study (TUTS), as the designated Metropolitan Planning Organization (MPO) for the Texarkana metropolitan planning area, is responsible for performing transportation planning activities within the Texarkana Study Area Boundary; and

WHEREAS, the Texarkana MPO is responsible for preparing and submitting this amendment to the FY 2023 – 2026 TIP to ARDOT for inclusion in the Arkansas Statewide Transportation Improvement Program (STIP) for FY 2023 – 2026.

WHEREAS, the Texarkana MPO Technical Committee approves the inclusion of Transit Section 5307 and 5339 funds for the fiscal year 2024 which were apportioned in fiscal years:

WHEREAS, the Texarkana MPO Technical Committee recommends the adoption and submission of the FY 2023 – 2026 TIP Amendment Three to the Policy Board to adopt and submit to ARDOT for inclusion in Arkansas' STIP for FY 2023 – 2026.

NOW, THEREFORE, BE IT RESOLVED by the Policy Board of the Texarkana MPO that:

SECTION 1: Transit 5339 Planning Funds are to be included in the fiscal year 2024 of the FY 2023 – 2026 TIP in the amount of \$96,662 for the Arkansas portion of the Texarkana Metropolitan Study Area is hereby adopted.

SECTION 2: Transit 5307 Planning Funds are to be included in the fiscal year 2024 of the FY 2023 – 2026 TIP in the amount of \$457,098 for the Arkansas portion of the Texarkana Metropolitan Study Area is hereby adopted.

SECTION 3: The Director of the Texarkana MPO is hereby authorized to submit Amendment Three of the FY 2023 – 2026 TIP for the Arkansas portion of the Texarkana Metropolitan Study Area to ARDOT.

SECTION 4: This Resolution shall become effective immediately upon adoption.
