AMENDING THE CENTRAL ARKANSAS REGIONAL TRANSPORTATION STUDY (CARTS)
FY 2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM**

WHEREAS, Metroplan is the officially designated Metropolitan Planning Organization (MPO) for the Little Rock-North Little Rock-Conway metropolitan area;

WHEREAS, the MPO is charged with the responsibility of developing and administering the Transportation Improvement Program (TIP) for the Central Arkansas Regional Transportation Study;

WHEREAS, the "Infrastructure Investment and Jobs Act" contains new discretionary grant programs;

WHEREAS, the City of Conway applied for and received a RAISE Grant for the "Connecting Conway Plan";


WHEREAS, the City of Little Rock applied for and received a Reconnecting Communities Pilot Program grants for the "I-30 Deck Park Phase I Planning Study";

WHEREAS, the Metroplan applied for and received a Safe Roads for All Grant plan for the development of a "Central Arkansas Safety Action Plan Action Plan";
