To become an eligible bidder, prospective bidders must be registered to bid in Arkansas with Bid Express. Prospective bidders must also contact the Program Management Division at (501) 569-2261 during regular business hours (or via email at pmd@ardot.gov) between the date the project is advertised and 4:30 p.m. on the day prior to the scheduled bid opening to request to become eligible to bid specific projects. Only prequalified contractors or their authorized representative may request to become an eligible bidder.

Questions pertaining to projects during the advertisement period should be addressed to the Program Management Division at pmd@ardot.gov. The deadline to submit a question is the Wednesday prior to the scheduled letting date. A question submitted after the close of business on the Wednesday prior to the scheduled letting date may not receive a response.

In order to have a bid considered, contractors must furnish a proposal guaranty consisting of either a bidder's bond or a certified or cashier's check in the amount of five percent (5%) of the total amount bid. In order for a bond to be acceptable to the Department, the company issuing the bond must be named in the Department of Treasury Listing of companies holding Certificates of Authority as acceptable sureties on Federal Bonds and as acceptable reinsuring companies. The Underwriting Limitation of the bonding company shall be adhered to.

Any excess (between the face amount of the Bond and the Underwriting Limitation) shall be protected by reinsurance provided by an acceptable reinsuring company.
